REQUREST For Proposal

The Incorporated Village of Shoreham is seeking an engineering firm for the purpose of producing an overall comprehensive plan for the refurbishment of its roads and 100-year-old drainage system. The intent is to guide the Village into the next decade in reducing stormwater runoff currently flooding into residential properties, the Village beach and Long Island Sound.

This plan and engagement should include the following:

- A. Review of existing road and drainage structures located in three sections of the Village;
- B. Redesign of drainage systems to include natural solutions and green infrastructure technology wherever practical;
- C. Calculation of stormwater retention resulting from the use of proposed green infrastructure technology and structures at higher elevations to quantify the reduced need for drainage structures at lower elevations;
- D. Preparation of a budget analyzing the effectiveness of improvements recommended by the Roads Infrastructure Committee and Green Infrastructure Committee. The analysis should include comparative costs for optimal selection of technologies;
- E. Coordination with the Road Infrastructure Committee and Green Infrastructure Committee for presentation of the plan to the Village Board;
- F. Preparation of written recommendations to the Village Board evaluating the bid and documentation required, including specifications for paving (asphalt and/or composite porous paving), drainage, curbing, milling, patching, seal cracking, etc;
- G. Submission of a proposal for project management and supervision of the plan as it is executed;
- H. Coordination with bond counsel and EFC loan and grant organizations to prepare documents that may be required to allow the Village to secure the best financing available;
- I. Preparation of the necessary feasibility study if a New York State Loan is sought.

- Analysis of bids and interviews of engineering firms

RIC Comments from Bob Reid

We all started this together and now it is drawing to a rapid end. I just got off the phone with Ed and he said he wanted to get together with us soon to get our input into the plan.

With that in mind I want to address something that I came up with recently. First the Village buys Bud Siegel's property for perhaps 400K, tears down the house, and uses the land for first drainage and second to replace the park by the tennis courts moving it to a safer and more quiet place there on Bud's old site. The drainage would recover and remove from the beach pipe all that area from Mary Jane Stangby's Roger Pajaki's and Louis Bellport's area via a pipeline from Pence's Driveway across and in front of Kallenback, Oliver's, Byer's etc to Siegel's. This would take off a huge amount of the runoff. Then we could through a smaller pipe collect the water from Knapp's, Kallenback, Oliver and that stretch of road down to Gill Tantrum's back yard and run across in front of Kullen's to Siegel's. This would be a simple run from the corner to the property. Lastly we could capture and run across Phillips front lawn to drainage again on Siegel's. All of this would effectively capture 50% of the old Village runoff and 95% from this area.

If the land is not purchased then nothing can be captured. Also by moving the playground it is far safer for children in the quieter old village, there can be 8 to 10 parking spaces and the catch basins can have what are called chimneys on the with locking tops (cast iron) and a planter on top and around for cleaning. We would have these in front of the parking area and along the street west side of the property. The basins by the gazebo would be buried with cast iron locking covers.

Where the existing park is we would be able to install a series of catch basins to capture a great deal of the water from Briarcliff that might get passed the natural recharge we called for on the corner of Tower Hill Rd. and Briarcliff on the school property. These two things would enable us to reduce substantially the water heading to the beach.

I have thought about the idea of using the ball field but the depth to the tops of the basins would all but make cleaning them virtually impossible. We could add a series right along Woodville and that would capture whatever water was coming from Beatty, Overhill areas and Ashley La. Those few catch basins would be along Woodville and have the steel /cast iron locking covers and be able to be cleaned.

On Ashley La we would get an easement from Bob Jamieson to allow us to build the "Runoff Troughs into the woods and then two additional catch basins on Dunnellon's and Abata's to capture a great deal of the water before getting to Woodville.

All of the above would remove the need for a pipeline down Woodville

These notes and observations include those inadvertently omitted from discussions with Green Infrastructure Committee and new thoughts pertaining to roads and drainage, to be combined with others on RIC.

- We would like a more detailed explanation on the proposed bio retention swale on the western side of Wardencliff Road south of Gridley Road.
- 2) It could be workable to add a trench drain across Gridley Road at a higher elevation (more west) than the 2 drains that are installed there now just west of Wardencliff Road and to pipe runoff from the new trench drain to the bio retention swale proposed on the west side Wardencliff Road. An easement across Phillips northeast corner might be needed for this drainage system to work or the pipe might be able to stay in the right of ways.
- 3) It could also be workable to add a large amount of capture under the bio retention swale all along the western right of way on Wardencliff Road to capture all the water coming down the pipe through the Bud Siegel Estate's yard from the intersection of Tagliabue Road and Prospect Street. A preferred path for the rerouting of this pipe in the Bud Siegel Estate's yard would be to route the pipe from a redesigned & upgraded drain at Tagliabue Road and Prospect Street north to the property line and then east down the property line to the proposed bio retention swale on the west side of Wardencliff Road. An easement would be needed for this to happen but would be helpful to get the flow away from the present pipe's path right next to the Bud Siegel Estate's house which has been flooded in the passed due the present configuration of the pipeline.
- 4) The present drain line is only 8"in diameter from this drain at Prospect Street and Tagliabue Road. The 8" pipe is also serving the house at this time with a drain in the yard/walking path leading to it just at the northwest corner of the Siegel house. The preferred approach would be to leave the present pipe in place in the ground only from the corner of the house and end it in the bio retention swale on the west side of Wardencliff Road. The east end of the old pipe under the south portion of the Spier house on the east side of Wardencliff Road should be fully abandoned. (Plugged with concrete).
- 5) All the runoff coming down the south end of Tagliabue Road to Fitzgerald Road and all runoff from the north end of Beatty Road and the south end of Prospect Street could be diverted with a large trench drain across Fitzgerald Road just

PART ONE

These notes were prepared following discussions among members of the GIC of the Engineer's Report. Although we understand that the first phase of the project is to repair the roads and storm-water runoff issues in the "Oldest" part of the Village, we commend the approach of considering the entire Village as a whole.

If most water can be diverted in an inexpensive way by using green infrastructure solutions, we feel that this will be more cost effective than creating a drainage system that bypasses all homes. In addition it may help extend the longevity of the new roads, reduce pollution going into Long Island Sound and make the Village better able to weather huge rainfall events.

- 1) Get more explanation on proposed bioswale for Wardencliff, South of Gridley. There already is a pine tree hedge and arborvitae hedge in much of the designated area. We have not observed significant run off on any part of this road, with the exception of the length of road from the drain near Wardencliff's intersection with Gridley. When looking South on Wardencliff from Gridley intersection, one can see that the drain is in the high point in the road and the road's crown breaks toward the "Stop" sign. See images 1,2,3 and 4.
- Consider shifting the bioswale south along Bud Siegel's property. This may also involve an easement.
- 3) Consider bioswale closer to source of runoff, at the intersection of Prospect and Tagliabue. Water from Tagliabue, South of Gridley goes in two directions along Tagliabue. From near mid-point along Tagliabue, it slopes toward Prospect. See images, 5,6,7 and 28. From mid-point along Tagliabue, the water flows toward Fitzgerald, the water runs down North side of Fitzgerald, overfills drain and continues across Wardencliff to drains before reaching Woodville. One drain is in front of Gil Tastrom's house Water also drains down Beatty to Fitzgerald on the South side and drains at Lee Frei and Drew Tyler's house on Fitzgerald, West of Wardencliff. See images, 13,14, 15, 18, 19 and 20.
- 4) Consider small bioswales or rain gardens on the water route down Prospect to Tagliabue. Water comes down from Prospect and the South-western part of Tagliabue to the drain in front of 5 Tagliabue (Siegel). We understand that these may be small GI features, but they could have a significant impact. See image, 10 and 28.
- 5) Image 8 is an example of where a home-owner could build a small rain garden.
- 6) Proposed bioswale on Wardencliff at Thompson is a good idea. All our observations support the evidence in the Report. See images, 21, 22, 23, 24, 25,26, and 27.
- Consider a bioswale in the "Y" at the intersection of Beatty and Overhill if site is appropriate. The Engineer's may have evidence to support why this was not proposed.



It was good talking to you before the Holidays. Thank you for getting back to me.

As we discussed, the Village of Shoreham is planning to undertake a major road and drainage project to be phased in over the next three years. McLean Associates has been hired to help us with this effort.

As a first step, McLean has prepared the attached plans and estimates addressing stormwater runoff that ultimately flows through an outflow pipe at the Village Hall directly into Long Island Sound. Our engineers have told us that their plan will significantly mitigate this runoff. It's indeed a creative design that can only improve the environment.

A small community like ours can't afford anywhere near what it would take to undertake a drainage project of such nature, not to mention the additional cost to refurbish roads and curbing. Noteworthy, as well, is the fact that much of this runoff comes from Town properties and roads, only exacerbating the drainage problem the Village has faced for years.

So we need your help. We understand there will be funding available through the State, initially for drainage projects and later for roadwork. Whatever you can do to help us qualify for such funding would of course be more than appreciated. We realize we're talking about a significant grant, but then again there's significant environmental gain to be had.

Given the unique nature of what our engineers are proposing and the positive effect it will have, we'd be happy to meet with you and appropriate State officials to further discuss the merits of the design. We think you'll find it interesting and worthy of consideration.

Mayor to hold open forum Saturday

Shoreham Mayor Ed Weiss has announced plans to hold his second open community forum at 9 a.m. on Saturday at Village Hall, 80 Woodville Rd.

Weiss said Thursday he plans to discuss the village's road improvement project and efforts to update village codes.

"We're trying to look at our laws and making them current. We have a major road drainage project currently underway," said Weiss, a Manhattan real estate company executive who was elected mayor in June. "It's just to get together and say hello to one another and review some projects and talk about where we're headed."

The village board in March approved a \$1.6 million plan to improve village roads, including curbs, sidewalks and drainage. The project is to be paid for with taxes and up to \$995,000 in serial bonds.

Weiss said he held a previous forum last fall that was attended by about 40 people. Many of those who attended expressed Irizarry. Follow me for stories about government, politics, technology, schools and businesses.
